



## Enter to Win - St. Patrick's Day 2024 Sweepstakes

### OFFICIAL RULES

**AFFINITY FEDERAL CREDIT UNION (“the Credit Union”) ST. PATRICK’S DAY 2024 SWEEPSTAKES CONTEST OFFICIAL RULES NO PURCHASE, OBLIGATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** “St. Patrick’s Day 2024” Sweepstakes (the “Sweepstakes”) is open to legal residents of the state of New Jersey, New York, and Connecticut. Void in all other locations (including but not limited to AZ, FL, RI, TX, and Puerto Rico), and where prohibited or restricted by law. Entrants must be 18 years of age or older at the time of entry in the Sweepstakes. Employees, officers, and directors and their immediate family members including spouse, parent, child and sibling and their respective spouses, regardless of where they reside, and members of the same household, whether or not related to the Credit Union and their respective parents, affiliated companies, subsidiaries, licensees, members distributors, dealers, retailers, printers and advertising and promotion agencies, and any and all other companies associated with the Sweepstakes are not eligible to participate or win a prize. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations.

**HOW TO ENTER:** The Sweepstakes begins at 12:00:00 AM EST on 03.09.2024 and ends at 11:59:59 PM EST on 03.31.2024 (“Entry Period”). During the Entry Period, there is one (1) way to enter: via on-line form submission method. In the event of a dispute as to the identity or eligibility of a Winner based on an e-mail address, the winning entry will be declared made by the “Authorized Account Holder” of the e-mail address submitted at the time of entry provided he/she is eligible according to these Official Rules. The “Authorized Account Holder” is defined as the natural person to whom the applicable Internet service provider or other organization (such as a business or educational institution) has assigned the e-mail address for the domain associated with the submitted e-mail address. The Credit Union reserves the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Sweepstakes.

**DRAWING:** The 6 potential winners of the Sweepstakes will be selected by a random selection. Six (6) winners will be selected for entries from 03.09.2024 to 03.31.2024 and notified by 04.30.2024. Winner need not be present to win. Odds of winning depend on the total number of eligible entries received. Limit one (1) prize per person, family and per household.

**PRIZES:** Six (6) prizes are available to be awarded. Winner will receive One (1) gift card to a local restaurant (total retail value of \$100). The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes) and may be required to submit a signed IRS W-9 form to the Credit Union. The odds of winning depend on the number of entries received.

**NOTIFICATION:** The winner for entries from 03.09.2024 to 03.31.2024 will be notified on or about 04.30.2024 by e-mail, and/or telephone at the sole discretion of the Credit Union. In the event that any potential Winner does not respond to any such notification within seven (7) days of date of issuance, a disqualification will result, Prize will be forfeited and, at the Credit Union’s sole discretion and time permitting, an alternate potential Winner may be chosen from among all remaining eligible entries.

**WAIVER OF LIABILITY/PUBLICITY RELEASE:** By participating in the “St. Patrick’s Day 2024” Sweepstakes and submitting an entry, each entrant agrees to be bound by these Official Rules. All disputes will be resolved under applicable U.S. laws in the state of New Jersey without giving effect to choice of law or conflicted law principles (whether of the state of New Jersey, or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the state of New Jersey. The Credit Union's failure to enforce any terms of these Official Rules shall not constitute a waiver of that provision.
